(a) 日期 Date : 2021 年 5 月 8 日 (週六 Saturday)

(b) 時間 Time : 上午 9:00 - 9:45 (第一節 Session 1) / 上午 10:30 - 11:15 (第二節 Session 2) / 中午 12:00 - 12:45 (第三節 Session 3)

(c) 地點 Venue : 本中心六樓多用途活動室 (MPA, 6/F, ATEC.)

(d) 所有申請者 **必須憑准考證** 出席音樂能力測試的 **指定場次**。缺席考試者的申請將不獲考慮。All applicants **must** attend the **designated session** of the Music Aptitude Test with the **Admission Slip**. Applicants who fail to attend the Music Aptitude Test will not be considered for admission.

(e) 試卷範圍 Scope of Test paper : 基本樂理、西洋音樂、中國音樂、粵劇音樂及流行音樂基礎知識 Basic rudiments, basic knowledge of western music, Chinese music, Cantonese operatic music and popular music

(f) 試題形式 Question format : 聆聽題、短答題 Listening questions, short questions
