高中(香港中學文憑試)音樂科課程 SS (HKDSE) Music Course 2024-2025

中四級音樂班報名 Application for S.4 Music Class

常見問題 Frequently Asked Questions

(1) 問:音樂科課程每學年/每月的學費是多少? Q: How much is the annual/monthly fee of the Music Course?

答: 我們不會向修讀本中心音樂科課程的學生收取任何學費。 A: We will not collect any fee from students taking the Music Course of our Centre.

(2) 問:報讀音樂科課程需要具備什麼資格? Q: What qualification should be possessed in order to be eligible to apply for the Music Course?

答:已考取五級樂理及五級樂器水平的中三學生為佳。 A: Current S.3 students who preferably have already attained Grade 5 Music Theory and Grade 5 standard on a musical instrument.

- (3) 問:每班音樂班有多少學生? Q: How many students are there in each Music Class? 答:平均每班音樂班有大約 20 位來自不同學校的學生一同上課。 A: There are approximately 20 students by average coming from different schools having lessons together in each Music Class.
- (4) 問:音樂班的課時安排如何? Q: What is the lesson time arrangement of Music Class? 答:每班音樂班每週上一堂三小時課堂。 A: Each Music Class will have a weekly three-hour lesson.
- (5) 問:選修香港中學文憑試音樂科有什麼考慮因素? Q: What are the factors for choosing HKDSE Music as an elective subject?

答:學生應考慮本身的能力、時間分配及諮詢原校有關高中課程選修科組合的安排。A: Students should consider own ability, time allocation and enquire own school on the combination and arrangement of senior secondary elective subjects.

- (6) 問:香港中學文憑試音樂科課程的校本評核部份有什麼要求? Q: What is the requirement of the School-based Assessment of the HKDSE Music Curriculum?
 - 答:香港中學文憑試音樂科課程沒有校本評核部份,只有卷二及卷三的外評部份。A: There is no School-based Assessment for the HKDSE Music Curriculum, but only External Assessment of Paper 2 and Paper 3.
- (7) 問:學生原校的職責為何? Q: What is the responsibility of student's own school?

答:學生原校應委任一位聯繫老師負責跟進學生在音樂科的學習進度。聯繫老師亦需負責安排學生音樂科卷二的錄影工作。學生須經原校向香港考試及評核局報名應考香港中學文憑試音樂科考試及呈交卷二及卷三外評所需的內容。 A: Student's own school should appoint a Liaison Teacher to follow up the learning progress in Music of the student. The Liaison Teacher also needs to administer the video recording of Music Paper 2. Student must register for HKDSE Music Examination and submit the contents required by External Assessment of Paper 2 and Paper 3 to HKEAA via own school.
